

# Statutory Declaration



This statutory declaration must be signed and dated in front of an authorised person.

Bring the following documents to the authorised person:

- Proof(s) of residence/identity
- IRD summary of earnings for the last 12 months.

This declaration must be made in front of a person authorised to do so by the Oaths and Declarations Act 1957. If declared in New Zealand, an authorised person can include a Justice of the Peace; Barrister and Solicitor of the High Court of New Zealand; Notary Public; Registrar and Deputy Registrar of the Supreme Court, Court of Appeal, High Court or District Court; Member of Parliament or a Registered Legal Executive (fellow of NZILE).

solemnly and sincerely declare that:

1. I have read and meet the KiwiBuild Eligibility Criteria.
2. I intend to own the KiwiBuild home and to reside in it as my principal place of residence for the minimum required ownership and residency period, from the date of settlement.
3. HOME OWNERSHIP (applicant to confirm by ticking)  
 I do not own or have a legal or beneficial interest in a home in New Zealand or overseas, either alone or jointly with any other persons or entities (unless it is a beneficial interest of the type permitted in the Eligibility Criteria); or  
 I currently own or have a legal or beneficial interest in an existing home in New Zealand or overseas, either alone or jointly with other persons or entities, but I will not own a home or have a legal or beneficial interest in an existing home at the time I settle on the purchase of a KiwiBuild home.
4. RELATIONSHIP PROPERTY (applicant to confirm by ticking)  
 I am not married to, nor in a civil union or de facto relationship with someone who owns a home or who has a legal or beneficial interest in a home in New Zealand or overseas

5. RESIDENCY (applicant to select by ticking)  
A. I am a New Zealand: **and** I attach as **Annexure A**, a certified copy of my:  
 Citizen  Passport  
 Permanent Resident  Birth Certificate  
 Ordinarily resident  Passport and Visa  
 Citizenship Certificate  
OR  
 B. I do not meet the requirements in 4A - but I am in a married, civil union or de facto relationship with a person who does; and the KiwiBuild home will be relationship property with that person (as defined in the Property (Relationships) Act 1976); and I attach as **Annexure A**, a certified copy of my passport.
6. My total gross income from all sources (however arising and prior to any deductions for tax or any other deductions/expenses) in the 12 calendar months immediately prior to the date of this Statutory Declaration for salary and wage earners, or, in the previous tax year if you are self employed, is not greater than \$120,000 for a single buyer or \$180,000 for two or more buyers; and I attach as **Annexure B**, a copy of my IRD summary of earnings for the last 12 months.
7. I agree that if I purchase a KiwiBuild home I will sign a non-negotiable KiwiBuild Deed of Covenant and return that document to Kāinga Ora prior to settlement.

(Do not complete the following section until you are with the person witnessing your declaration.)
